# 2017

#### WEST CHESTER TOWNSHIP

 Voice of America - Began construction of the sponsored UC Health/West Chester Hospital Fieldhouse (also using grant funding)

#### FAIRFIELD TOWNSHIP

• Rentschler Forest -Completed a 0.5 mile extension of the Great Miami River Trail to Reigart Road (using grant funding)

#### CITY OF MIDDLETOWN

Began construction of River Center at Bicentennial Commons

#### BUTLER COUNTY

New main signage with new logo at all parks

#### **MADISON TOWNSHIP**

- Chrisholm Historic Farmstead Held the groundbreaking for the educational farm attraction and completed a nature playscape
- **Meadow Ridge** Completed acquisition and began restoration of the 456 acre Meadow Ridge area
- **Elk Creek** Completed a streambank stabilization in the Sebald Park area

#### **MORGAN TOWNSHIP**

- Governor Bebb Completed a streambank stabilization and relocation of the park road leading toward the Campground and Murstein Cabin
- Salamander Run Completed acquisition of the 126 acre Salamander Run Preserve Property

- Rentschler Forest
  - Completed a 0.3 mile extension of the Great Miami River Trail along the Boat Club Road through the Line Hill Mound area (using grant funding)
  - Began design of the 0.7 mile extension of the Great Miami River Trail to the Timberhill area

#### **MADISON TOWNSHIP**

- Elk Creek Completed restoration in Meadow Ridge Area and opened the area to the public (using grant funding)
- Chrisholm Continued design and construction of the Farmscape educational farm attraction

#### CITY OF MIDDLETOWN

• Bicentennial Commons

> Completed the River Center (using grant funding)

#### **CITY OF HAMILTON**

- Forest Run Completed a 1.3 mile paved multi-use trail, new improved main entrance, additional park entrance from Warvel Road and additional parking at the Timberman Ridge area (using grant funding)
- **Gilmore** Was awarded a \$750,000 Federal Transportation Alternatives grant, and partnered with the City of Hamilton on an additional \$510,064 Federal grant, toward future construction of the Miami 2 Miami Connection paved multi-use trail



Occurred in Elk Creek, Forest Run, Four Mile Creek, Governor Bebb, Salamander Run Preserve, Indian Creek, and Voice of America MetroParks

#### NATIVE PRAIRIE AND GRASSLAND

- **6** Acres preserved at Mill Race of Four Mile Creek




