- 1. Use of the facility is only for the date and time period stated on this License Agreement. Camping is permitted in designated areas only.
- Person obtaining this License Agreement must be 18 years or older & is responsible for organization's/group's conduct and respect for the
  facility. Violation of rules and regulations or abuse of the facility will cause this License Agreement to be revoked and no future license
  agreements will be issued.
- 3. Alcoholic beverages are strictly **PROHIBITED**.
- 4. Due to invasive species firewood may **NOT** be brought into the park. All firewood must be purchased through MetroParks and is available for \$7/bundle, a bundle has approximately 9 pieces of wood. Additional firewood can be purchased up until 2:00pm prior to your reservation date by calling the MetroParks Administrative Office Monday-Friday from 8:30am 2:00pm at (513) 867-5835. Fires are to be built only in the places provided. Outside fire rings are to be left in place. Never leave fires unattended. Please be sure to thoroughly extinguish all fires when you leave the facility.
- 5. Please leave the building and grounds in the same condition as when you arrived. We ask that you clean-up any large messes and deposit all trash in the containers provided. The individual signing the License Agreement agrees to be fully responsible for all damages, expenses, and losses, including theft and property loss caused by any person who attends, participates in, or provides goods and services connected with the use of the facility and all tangible property. Any such costs will be assessed and charged to the Licensee(s). Additional fees incurred due to clean-up or repair of facility beyond normal janitorial service will be charged at the rate of \$150 per hour. Any area not left in proper order and repair will be cleaned and repaired by the park district as necessary and the Licensee agrees to be billed and shall be liable for any and all costs.
- MetroParks Division of Police and other law enforcement officers patrol this site regularly. In case of emergency dial 911. For urgent issues that need immediate attention <u>after office hours</u>, please call <u>Butler County Sheriff's Department non-emergency dispatch at (513) 785-1300 ext. 9.</u>
- 7. Campers with pets must clean up and dispose of excrements in dumpsters. Pets must be kept on a leash, no longer than 6' in length.
- 8. Quiet hours are from 10pm-7am. Electronic devices and voices must be kept down so as not to disturb others.
- 9. Cancellation requests must be submitted in writing at least 30 days prior to scheduled date of use. MetroParks will attempt to reschedule use if possible. If not possible, a full refund will be issued within 4-6 weeks. If cancellation occurs less than 30 days prior to scheduled date of use, MetroParks will try to reschedule, but no refund will be issued if a rescheduled date, which is mutually agreeable to both parties (the licensee(s) and MetroParks) is not found. MetroParks will offer a credit minus the 10% processing fee to the user for them to use within one year of the cancelled date in the event both parties are unable to agree upon a rescheduled date.
